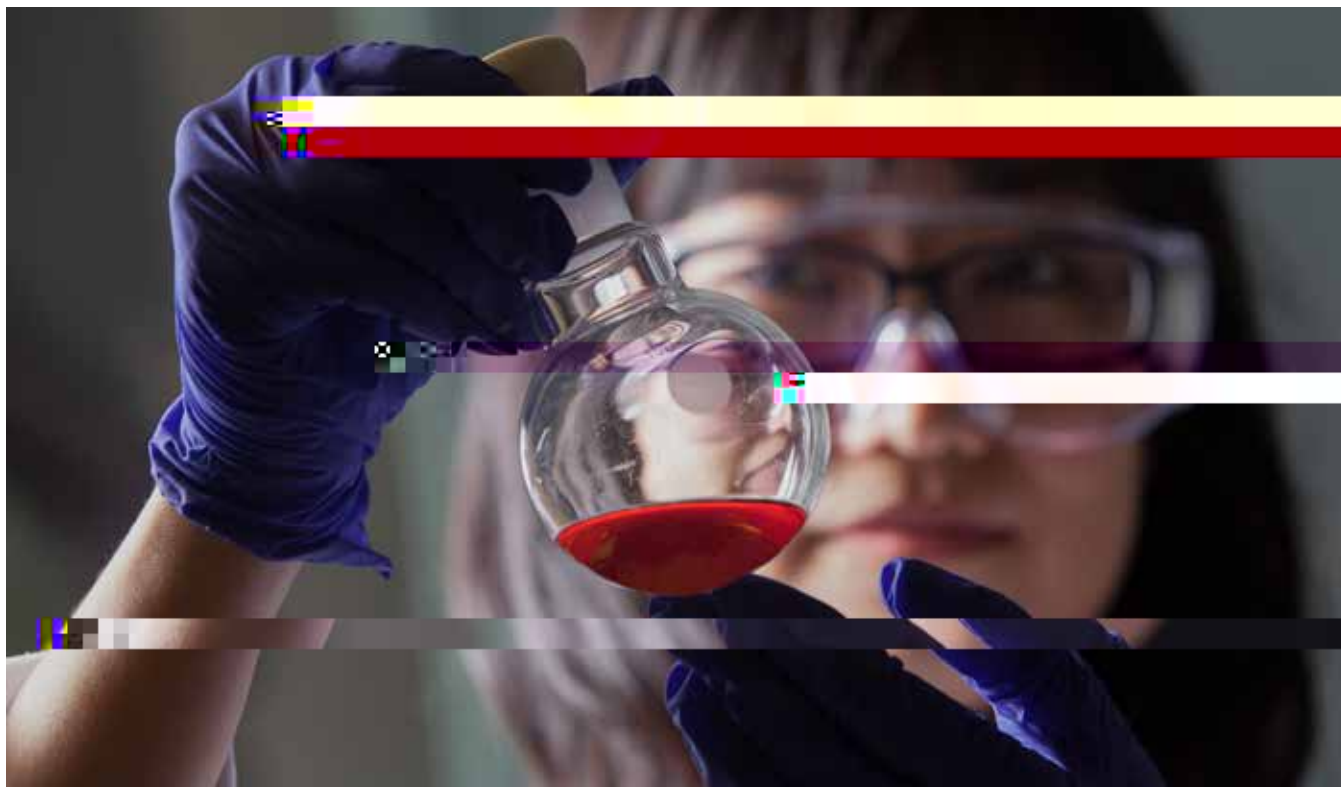


Responsible Investing

The Queen's Endowment is managed in accordance with the Responsible Investing Policy, as approved by the Board of Trustees. Decisions pertaining to Responsible Investing are made by the Board of Trustees to ensure the prudent investment of the university's assets. Queen's University is a signatory to the PRI and is committed to the principles of responsible investment.

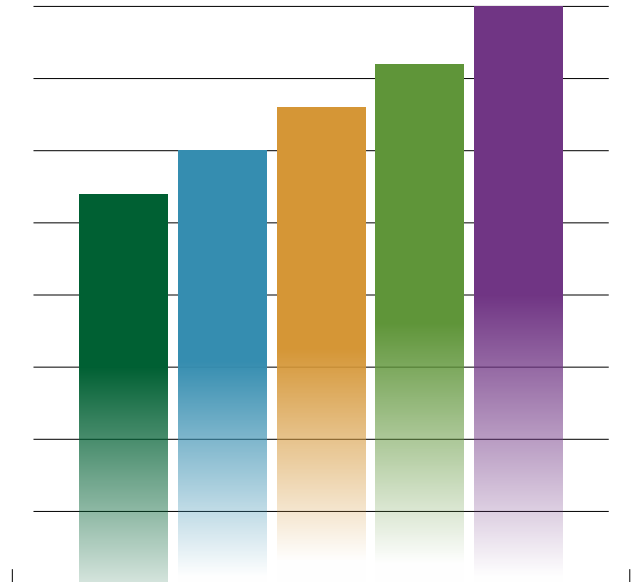
